Grid-Connected Heat Pump Water Heater Incentives

This category is for customers who meet all of the following criteria: (1) Replace a natural gas/propane unit with a HPWH with load-shifting capabilities; (2) Enroll in an eligible time-of-use rate; (3) Program HPWH to follow the time-of-use rate; (4) Enroll in an eligible demand response (DR) program, and (5) Enroll in a water heater rewards program.

To qualify for equity rates, customers must be enrolled on a CARE/FERA rate.
