Great News! CCCE is working with the local community to reduce regional emissions and build new, local, clean energy resources. The Slate Solar + Storage project, which formally launched this week in Kings County, California, is the first of CCCE's major investments in the development of new sources of long-term renewable power to reach commercial operation. CCCE submitted its second annual Supplier Diversity Report and Annual Plan to the California Public Utilities Commission. The report highlights several new initiatives to support small, local, and diverse business enterprises seeking to do business with the community choice aggregator.

CCCE's Energy Programs team is working directly with CCCE customers

by providing rebates and incentives to electrify their homes or business. In this fiscal year alone, CCCE is making \$14 million available to customers through Energy Program rebates and incentives:

- Incentives for electric-powered transportation, purchase and installation of chargers to power up EVs at homes and workplaces including labor and related electric panel updates or replacements are available to residents, commercial businesses, and public agencies until funds are allocated
- Incentives for Electric School Buses are available to all public schools and school districts in CCCE's service area until funds are allocated
- Incentives for new, all-electric agricultural equipment
 available to agricultural businesses and ag-related businesses in
 CCCE's service area until funds are allocated
- Incentives for new, all-electric affordable housing units within the CCCE service area are available to developers until funds are allocated

PG&E's California Arrearage Payment Program (CAPP) Bill Credits Begin

Pacific Gas & Electric (PG&E) customers who qualify for the California Arrearage Payment Program (CAPP) can expect a one-time bill credit on their energy utility bill. Payments began in February and continue this month. The Department of Community Services and Development established the CAPP program in the 2021-2022 state budget to help residential customers reduce past due energy balances accrued during the COVID-19 pandemic. The program assists energy customers that had a past due balance of 60 days or more between the dates of March 4, 2020 though June 15, 2021. Customers do not need to apply.

Slate Solar + Storage Project Reaches Commercial Operation

One of the largest integrated solar and energy storage projects in California is now serving Central Coast Community Energy, Bay Area Rapid Transit, Silicon Valley Clean Energy, Stanford University, and the Power and Water Resources Pooling Authority. Canadian Solar's fully-owned subsidiary, Recurrent Energy developed the Slate solar plus storage project in Kings County. The 390 solar plus 561 MWh storage project is expected to produce enough electricity to power about 126,000 households in California. Of all the Power Purchase Agreements (PPAs) CCCE has signed, and among all the PPAs that are associated with new renewable energy projects, Slate is the first to reach commercial operation.

Supplier Diversity Report and Annual Plan

Central Coast Community Energy (CCCE) submitted its second annual Supplier Diversity Report and Annual Plan to the California Public Utilities Commission.In the past year, CCCE has launched several new initiatives to support small, local, diverse business enterprises seeking to do business with the community choice aggregator. CCCE is proud that almost 30% of its \$3.4 million in non-energy procurement spending in 2021 was with local vendors based within its 33-member agency jurisdictions.

"Walk the Talk": CCCE Employee Electrifies Heat Pump Water Heater

Meet Dan Bertoli. He is the Manager of Energy Programs at Central Coast Community Energy (CCCE) and lives in Marina, CA. In his home, he recently replaced his 13-year-old gas heat pump water heater with an

electric model. "I participated in the TECH Clean California program and worked with a great contractor to replace my heat pump water heater," Bertoli said. "My old gas heat pump water heater cost about \$400 per year to operate. My new electric one costs about \$113 per year and is more efficient."



Bertoli installed a 200-amp electrical panel last year in his home to accommodate his electric vehicle charger. He said the panel made it easy to handle the electric heat pump water heater. "It feels good to go electric and reduce my home's greenhouse gas emissions and carbon footprint."


