Department of Water Resources Bond Charge

The **Department of Water Resources Bond Charge (DWRBC)** is the Wildfire Fund Non-Bypassable Charge which supports the California Wildfire Fund. The DWRBC was set to expire in 2021, but was extended for 15 years to establish a wildfire liability fund. This charge is assessed to all customers, including SCE-only customers, but is collected separately for CCA customers. The funds go to the State of California for potential disbursement to IOUs, such as SCE, if a catastrophic event occurs.

Competition Transition Charge

The ongoing **Competition Transition Charge (CTC)** recovers the CPUC-approved market price limit for legacy electricity contracts (signed prior to 1998), as well as statutorily authorized costs that are related to restructuring of California's electric industry prior to the energy crisis. These charges are assessed to all customers, including SCE-only customers, but are collected separately for CCA customers and go directly to SCE.

Fixed Recovery Charge

The **Fixed Recovery Charge** is a new charge that SCE uses to repay the SCE issued bonds meant to enable SCE to recover more quickly certain costs related to preventing and mitigating catastrophic wildfires, while reducing the total cost to its customers. This charge is assessed to all customers, including SCE-only customers, but is collected separately for CCA customers.

Generation Municipal Surcharge

The **Generation Municipal Surcharge** is the franchise fee paid to municipalities by all customers to cover the costs of allowing SCE to utilize electrical distribution lines throughout the city property. SCE acts as the collection agency for the GMS. The GMS factor is 0.009261 and is calculated by multiplying the factor by the SCE rate.

Power Charge Indifference Adjustment

The **Power Charge Indifference Adjustment (PCIA)** is a fee collected by SCE and assessed to customers who receive their electric generation services from another provider. The PCIA is considered an "exit fee" assessed by SCE to cover costs for departing customers; resources acquired prior to a customer's change in service providers, and to ensure their current customers are "indifferent" to costs associated with the departed customers. SCE assigns customers a "PCIA Vintage" based on the date a customer's respective community enrolled in alternative service; this date is reset upon reenrollment if a customer opts-out and later re-enrolls in CCCE service. The PCIA is charged on a per kWh basis based on net monthly usage, and is unaffected by time-of use.
