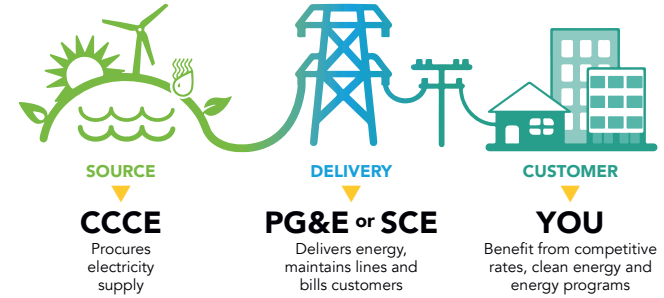
Where Does Your Power Come From?
