- Homes and residential buildings receiving service from 3CE
- Low-income applicants receive extra rebates

## WHY ELECTRIFY?

1. Submit claims through the TECH portal at [catechincentives.com](https://catechincentives.com)
2. Select "Heat Pump HVAC" or "Heat Pump Water Heaters" for single-family claims
