3CE's Annual Meeting Highlights Accomplishments, Energy Programs



Central Coast Community Energy (3CE) held its Annual Meeting of the Policy and Operations Boards Sept. 18-19 at the Seaside Resort in Aptos. The event kicked off with a welcoming address from Senator John Laird (17th District) and featured a keynote speech by Katerina Robinson, Chief of Staff at the California Energy Commission, who emphasized California's advancements in the Energy Transition.

Following her presentation, two engaging panel discussions were moderated by Jena Price, former Legislative Director at the League of Conservation Voters and founding partner of Tratten Price Consulting. The first panel explored the challenges and opportunities within the clean energy landscape, while the second focused on effective strategies to advance climate and clean energy goals.

3CE leadership highlighted achievements from the past fiscal year and outlined goals for the upcoming year. Notable initiatives include the launch in July of 3CE's first [Residential Battery Rebate Program](#), which has allocated \$2 million for 3CE customers and has already received 26 applications. The [Plan Your Fleet Program](#) will expand from five to nine agencies, while our [Agricultural Electrification](#) and [Electric Bus Programs](#) will allow multiple rebates for customers. Customers applying for rebates will experience a seamless process during the fiscal-year transition.

The Boards also approved 3CE's [budget](#) and Annual Rate Plan for fiscal year 2024-25. 3CE customers in SCE's service territory will transition to a Cost-of-Service rate model, aligning them with customers in PG&E territory.

Fiscal Year 2023-2024 Key Accomplishments

- The City of Atascadero and unincorporated San Luis Obispo County will be enrolled into 3CE service in January 2025. This expansion unifies the Central Coast with a public option for electric generation procurement.
 - 3CE continues to drive incremental renewable resource development that moves the agency closer to its 100% renewable goal while helping to lower and stabilize customer costs.
 - In the last year, 3CE added 205 MW of onshore wind generation, 500 MWh of energy storage, and 177 MWh of hybrid energy storage designed to reduce existing natural gas generation.
 - 3CE's operating projects avoided approximately 410,000 metric tons of CO₂ emissions last year alone, equivalent to the greenhouse gas emissions from more than 97,500 gasoline-powered passenger vehicles driven for one year.
 - The agency improved market scheduling operations to ensure that these and future resources are optimized to achieve the greatest customer benefit.
 - 3CE's [energy programs](#) are improved and expanded to help accelerate climate action with a new management tool to streamline and enhance customers' experiences with energy programs.
 - Working with its Community Advisory Council, 3CE performed a critical review of current offerings and evaluated the feasibility of demand-response programs. The new [behind-the-meter battery incentive program](#) will offer customers greater control over their energy consumption.

3CE Supports National Drive Electric Week



[National Drive Electric Week](#) runs from September 27 through October 6. In California, emissions have dropped 2.4% from last year, with fully half of the decline coming from the transportation sector. The drop is attributed to an increase in electric vehicles (EVs) and more efficient fuel.

On Sept. 26, Central Coast Community Energy (3CE) attended the City of San Luis Obispo's Farmer's Market and its [Electrify Your Life EV Showcase](#). An entire city block was cordoned off for an EV showcase which included 11 different models of electric cars and trucks. EV owners got a chance to show off their cars and talk about the joys of driving electric. The Showcase included Information booths offering detailed information about EVs and how to find the best rebates, tax credits, and discounts.

In partnership with the city, 3CE Customer Accounts Manager Jeff Railsback and Communications Specialist Meridith Cook represented the agency with a table at the Showcase, answering questions about rebates, home and transportation electrification, and the upcoming expansion of 3CE into unincorporated SLO County. They met lots of people who are EV curious and were excited to hear about 3CE's rebates for EVs and chargers. They also met lots of existing 3CE customers, and many who are excited to become 3CE customers in January.

3CE is supporting the transition to all-electric rides with our energy programs – and partnerships with our Member Agencies at the city and county level can be especially impactful. This month, our Programs team announced that Santa Barbara County will receive \$130,000 in rebates for installing 26 electric vehicle (EV) chargers through our [Charge Your Fleet Program](#), and Santa Maria will receive \$14,000 in rebates for purchasing two electric trucks through our [Electrify Your Fleet Program](#). Fleet managers from the City of Atascadero and San Luis Obispo County also met with 3CE staff to review 3CE's fleet electrification planning and rebate programs.

To raise the bar above the state's goals, Goleta has passed new rules requiring more EV charging stations in future building projects. With help from 3CE's [Reach Code Program](#), the city amended its Municipal Code to adopt an Electric Vehicle Reach Code.
