## 3CE Rates in PG&E Territory

### POWER CHARGE INDIFFERENCE ADJUSTMENT (PCIA) & Franchise Fee (FF)

The Power Charge Indifference Adjustment (PCIA) is a fee collected by PG&E and assessed to customers who receive their electric ENERGY services from another provider. The PCIA is considered an "exit fee" assessed by PG&E to cover costs for departing customers; resources acquired prior to a customer's change in service providers, and to ensure their current customers are "indifferent" to costs associated with the departed customers. PG&E assigns customers a "PCIA Vintage" based on the date a customer's respective community enrolled in alternative service; this date is reset upon reenrollment if a customer opts-out and later re-enrolls in CCCE service. PCIA rates are generally updated by PG&E each January. The PCIA is charged on a per kWh basis based on net monthly usage, and is unaffected by time-of-use. The below rates are effective January 1, 2026.

The Franchise Fee is collected by PG&E to pay for the right to use public streets for running gas and electric service through. This fee is imposed by cities and counties for all customers (including PG&E-only customers) but is collected separately from CCA customers. The Franchise Fee is charged on a per kWh basis, based on net monthly usage and is unaffected by time-of-use, nor will any city or county receive less from the Franchise Fee if they join a Community Choice Energy agency. The below rates are effective January 1, 2026.
